

DRS League Meeting Minutes
April 19, 2022 - 7pm Doublewide Bar
421 St. Joseph St. Elko New Market, MN 55054

The meeting was called to order by President Sticha at 7:02pm. Roll Call showed all teams represented except for Faribault. Per league by-laws, they will incur a \$50 fee payable to the League. Penalty has been acknowledged and accepted by Faribault.

Secretary's Report - Sean O'Neill

- 1. Approve last Meeting's Minutes. Motion Union Hill and second by Elko to approve. 12-0 approval of minutes.
- 2. Updates to the team contact information were requested and received.

<u>Treasurer's Report - Chris Hertaus</u>

1. The League financial update was given. Balance of \$4,224.35 was reported. All expenses are current. Motion Montgomery and second by Union Hill to approve. 12-0 approval of report.

Old Business

- 1. Schedule Poster/Ad payments. Managers were reminded to get these collected and turned into Chris Hertaus. Please proved details of receipt when submitting to Chris.
- 2. Bar Cards. There are 400 remaining, if teams would like to sell more. See Nick Schoenecker to secure.
- 3. Advertising on KCHK. KCHK will cover the regional and state tournament. It is unknown today how many regular season games will be covered. KCHK is requesting a \$500 advertising package from the DRS League. Motion Montgomery and second Shakopee to go ahead with the package provided that KCHK incorporates weekly scores and schedules into their broadcasts. 9-3 vote approves the motion. President Sticha will relay this to KCHK and report back to the League.

New Business

1. MBA updates

- a. New Player Ejection rule from the MBA was reviewed. After discussion, the league decided to further clarify the rule for our teams. Motion St. Patrick second by Shakopee the following. Any person in uniform, player or coach, is subject to the two-game suspension for ejection. The manager, unless he has played in the game, will still be exempt from the suspension per State rule. Motion approved 11-1. The DRS League Ejection policy will be amended to match this rule.
- Teams are reminded to maintain ScoreMonster items: schedules, rosters, game scores in a timely fashion. Teams were told to submit their game stories to the New Prague Times, if they want them published. It is no longer the home team's responsibility. Home or Away team can submit and are encouraged to do so.
- 3. Region 3C Commissioner O'Neill and President Sticha will again work on the format in the weeks ahead. It is likely to follow a similar format to the past few years. However, input from the DRS League teams is welcome. Eric Solheid Construction will again sponsor the online Region Bracket for \$150.
- 4. Next meeting of the DRS will take place in late June or early July, if needed. If it can be handled online, we will go that route.
 - a. Roster Approval can be done online, unless if a player eligibility is challenged. In that case, we will meet in person.
 - b. Final 30-man roster is due June 30th.
 - c. Final 25-man roster to be settled July 5th 11th timeframe.
- 5. Innovative Graphics will sponsor the online standings again in 2022 for \$500.
